DIRECTOR UPDATE	T. SAKRISON	T. Sakrison announced that the travel policy update is scheduled to take effect on February 1, 2015. Mr. Sakrison reminded the council of the CPD training in January at Lake Lanier Island. Announced that the training budget has been doubled for the upcoming year. Informed the council that the CJCC has extended the deadline for the drug enforcement surveys. Announced that Tracy Mullis was appointed CPD of the Cordele Circuit as of December 16 th . All CPD evaluations are complete, and follow-ups will take place in the near future. Conflict surveys are also due back in the near future. The upcoming CPD training will include grant training. Announced that Sue Nails is retiring at the end of the calendar year. The annual audit focused on banking, and the GPDSC is now part of a group of executive agencies using CTAS banking.
